

Activity

MONTH OF FEBRUARY 2017

SAFARI: We have two resolutions tonight regarding our work toward better flood resiliency. The first is concerning the possible relocation of the two buildings on Main St closest to the Stony Clove Creek which currently house Ruth Gale Realty and the Catskill Clothing store. We have received a \$15,000 grant from the CWC to perform a feasibility study. This relocation plan is part of a larger plan outlined in the Local Flood Analysis done for the Hamlet of Phoenicia last year.

We also have a resolution to hire a firm to assist us, and more specifically our Code Officer Warren Tutt, in completing an application through FEMA's Community Rating System or CRS. CRS is a program whereby communities can apply and, depending upon the depth of information, education and communication you provide residents, garner varying amounts of points. The more points you accrue the more you can reduce flood insurance rates for your residents Town-wide. Due to the amount of work and information we have available and provide to our residents regarding flooding currently, we believe we can work toward at least a 10-15% reduction in those costs for residents. We have received a \$15,000 grant from the Ashokan Watershed Stream Management Program and Cornell Cooperative Extension of Ulster County to perform this task.

We hope to receive proposals for both these activities before our next meeting and hope to award both at March's Board meeting

AMBULANCE: Last month we were forced to take emergency action to increase the wage for our drivers from \$9 per hour to the new State Minimum Wage of \$9.70 per hour. Previously our Technicians, or EMT's, were making \$1 per hour more than the drivers due to the increased training and service they provide. Tonight we have a Resolution to increase the EMT rate from \$10 per hour to \$10.70 per hour. We will be addressing the Paramedics over the next few months. These rates were set in their contract and we will need to address this in that contract for the coming years so as to continue to meet proposed Minimum Wage increases.

Additionally, one of our Full-Time Paramedics is taking an undeterminable "leave of absence" for personal reasons. We are promoting Part-Time Paramedic Jim Coddington to Full-Time to cover this loss, additionally Deputy Chief Muellerleile will be taking over the duties of Training Officer, which was being performed by the same individual.

BELLEAYRE: Belleayre Mountain located wholly within the Town, is operated by the Olympic Regional Development Authority (or ORDA) based in Lake Placid. They also operate two other facilities (Whiteface in Lake Placid and Gore Mountain in North Creek.) If you were not aware, it is Budget season in Albany. We were alerted to an announcement made by Governor Cuomo approximately two weeks ago

concerning Capital Funding to be provided to ORDA for their ski facilities. Regrettably, the announcement of a \$20 million investment proposed by the Governor was specifically slated for infrastructure and upgrades at Whiteface and Gore only, without mention of Belleayre. Belleayre is a vital part of our community and region and many residents and visitors are disappointed, to say the least, about this omission. A Unit Management Plan for repairs and upgrades at Belleayre was prepared over a number of years. In December of 2015 the plan passed environmental review and was approved by the State DEC, yet the state fails to fund the plan or even items in that plan. Just as we struggle to maintain the upkeep on our bridges, roads, buildings and vehicles. It is the State's responsibility to maintain the necessary infrastructure and improvements needed for Belleayre to maintain a safe and relevant recreational facility, like Belleayre. We have a resolution tonight to request the Governor to correct this omission as soon as possible and ask our County Legislature and County Executive to do the same.

HIGHWAY: We have a resolution to go out for bid for gravel crushing and hope to receive bids prior to our meeting next month in order to award.

Additionally, work is moving forward on the replacement bridge for Route 28 in Big Indian and Woodland Valley Bridge. We have a meeting coming up with DOT to discuss the full plan for the Big Indian Bridge, but it sounds like the plan remains to be building the new bridge next to the existing bridge. Motorists will continue to use the existing bridge, without a detour, and they hope to move the lanes onto the new bridge sometime in the summer of 2018. Woodland Valley Bridge is still slated to reopen this spring.

Additionally, we received notice that another of our bridges on Peck Hollow, which is in need of serious replacement, was awarded \$885,000 through the New York Bridges Program. We are meeting with DOT officials next week to go over the plan for replacement and hope to be going out over the next few months for that work. It should be noted that we were the only government, including the County, who received these funds in Ulster County.

MISC.: We have a resolution to renew our contract with the County for our Police Department to participate in URGENT (Ulster Regional Gang Enforcement Team).

I'm also happy to report that there is a resolution to hire a Full-Time Confidential Secretary for my office, since the previous Secretary left last September. Tonight we will be hiring Carol Herdman who comes to us with previous experience in Governmental accounting with the US Navy. I'd like welcome Carol aboard and also I would like to thank Tina Rice, who was helping out periodically and to Patti Heinz the Part-Time Secretary for taking on more of a workload until this point.

Lastly, our Franchise Agreement with Charter Communications/Spectrum (formerly Time Warner Cable) is due for renewal in May. We have several areas of the Town we would like to see service extended to and the State has requested that Spectrum find a way to provide many more properties, state-wide, with service and improved service to boot. Board member Storms and I will be meeting with a few folks over the month to review the current agreement and look for ways to try and provide better service throughout our community. If you are in an area of Town that is currently lacking in Television and Broadband Services, feel free to contact my office so we work toward creating a committee to work on this over the next few months.

Our next regular meeting is scheduled for Monday, March 6, 2017 at 7 pm.



TOTAL MILEAGE BY UNIT - 2016



SUPPORTING NEW YORK STATE FUNDING FOR BELLEAYRE INFRASTRUCTURE

WHEREAS, the Town Board of the Town of Shandaken recognizes recreational tourism as our biggest economic driver here within the Catskill State Forest Preserve; and

WHEREAS, Belleayre Mountain Ski Center (**BELLEAYRE**), located wholly within the Town of Shandaken and Ulster County, is a major economic driver for many of our communities, not just within Shandaken but along the Route 28 Corridor and the Catskill Mountain Scenic Byway communities; and

WHEREAS, BELLEAYRE is operated by the Olympic Regional Development Authority (ORDA), which also operates multiple recreational facilities throughout New York State including Gore and Whiteface Mountains located in the Adirondacks; and

WHEREAS, Governor Cuomo recently made an announcement concerning the upcoming New York State budget proposing \$20 million in capital investment for much needed upgrades and repairs at ORDA facilities, but specifically earmarked those funds for use at Gore and Whiteface Mountains excluding Belleayre; and

WHEREAS, New York State has already recognized the necessity for upgrades and improvements at **Belleayre** as outlined in the Unit Management Plan (**UMP**) and approved by the State in 2015; and

WHEREAS, BELLEAYRE has not been able to implement long-needed and awaited upgrades and repairs to the existing equipment and lodges for many years due to lack of capital funding; and

WHEREAS, the Governor has also reiterated in several statements and visits to our region, his understanding of the importance of **Belleayre** on the Central Catskills economy;

THEREFORE BE IT RESOLVED, The Shandaken Town Board formally requests the Governor to correct this oversight in his current 2017-18 NYS Budget proposal and provide capital funding for the much needed infrastructure upgrades at BELLEAYRE Mountain Ski Center; and

BE IT FURTHER RESOLVED, The Shandaken Town Board requests the Ulster County Legislature and Ulster County Executive, Honorable Michael P. Hein, provide support for the Town of Shandaken and **BELLEAYRE** on this issue concerning the single largest economic driver in western Ulster County and that a copy of this resolution be sent to the Governor's Office, Ulster County Executive and Legislature and our NYS Senator James Seward and Assembly Member Kevin Cahill.
