Summer is in full swing and with that comes droves of people from all over the land, and hot weather. Combine the two and our riverine community is the perfect setting for a great afternoon splashing in our plentiful waterways. At the sake of sounding like a broken record, there are inherent risks associated with swimming in the wild- mostly the fact that the river is unpredictable, and the current is not conducive to the novice swimmer. It also takes time for our rescuers to assemble and respond to a water emergency with our special equipment.. so before you decide to engage in cavalier activities on the water think about how long you can hold your breath. There has been an unprecedented number of drownings in the Hudson Valley this year, and many have been attributed to novice swimmers entering water they should not have been- particularly without a personal flotation device. Do not become a statistic and use common sense.

As my family and I are frequent visitors of our local swimming holes, we have also noticed that there is not only an uptick in garbage at these spots, but also a prevalence of glass bottles and fishing hooks/ line. PLEASE do not carelessly discard your refuse around streams. Not only is it terrible for our environment, but it also is a safety hazard as broken glass can easily end a summer for someone barefoot. Fishing hooks can cause a nasty wound, are tough to get out of whatever they enter, and can spread infection. Carry out what you carry in, do not bring glass bottles around recreation areas, and yet again utilize common sense.

COVID UPDATE- As of 7/2, there were 14 active cases of COVID in Ulster County- yet another all time low since the start of the pandemic. There are no cases in the Town of Shandaken at this time. Total cumulative cases in the Town since the beginning of the pandemic have reached 113, with all recovered. Total cumulative cases in the County have reached 15,231, with a total of 265 fatalities. Ulster County is 58% fully vaccinated at this time, 63.3% with at least one dose of the Pfizer or Moderna two-dose series, and 73% of the 18 year and older population with at least one dose.

RESOLUTION TO AWARD AMBULANCE BID AND AUTHORIZE FINANCE OPTION

WHEREAS, the Town of Shandaken Ambulance Department accepted a bid for a replacement Ambulance Vehicle on June 6th, 2021 from **Northeastern Rescue Vehicles– 10 Dwight Park Dr. Syracuse, NY 13200** at the Town Board meeting on June 7, 2021 for a price of **\$167,675.00**; and

WHEREAS, the specifications were reviewed by the Ambulance Chief and Deputy Chief and found to be acceptable.

THEREFORE, BE IT RESOLVED the Town of Shandaken Town Board award the bid to Northeastern for \$167,675.00

BE IT FURTHER RESOLVED, the new Ambulance Vehicle be financed in the amount of \$140,000.00 through a Statutory Installment Bond provided by Community N.A., 4141 NY-28, Boiceville, NY 12412 for eight (8) years following the issuance date (\$20,000 + Interest Annually); with balance (\$27,675) paid from existing appropriations within the Town of Shandaken 2021 FY Budget minus any proceeds from trade-in or sale of previous existing Ambulance.

AUTHORIZING THE IMPLEMENTATION, AND FUNDING IN THE FIRST INSTANCE 100% OF THE FEDERAL-AID AND STATE-AID ELIGIBLE COSTS, OF A TRANSPORTATION FEDERAL-AID AND/OR STATE-AID TRANSPORTATION PROJECT, AND APPROPRIATING FUNDS

WHEREAS, a Project for the Bridge Replacement of Peck Hollow Road over Peck Hollow Stream in the Town of Shandaken, Ulster County (BIN 2270000) identified as PIN 8761.61 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 95% Federal funds and 5% non-federal funds; and

WHEREAS, the Town of Shandaken will design, let and construct the Project; and

WHEREAS, the Town of Shandaken desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of right-of-way acquisition, construction, and construction inspection work.

THEREFORE, BE IT RESOLVED, that the Shandaken Town Board hereby approves the above-subject project; and

BE IT FURTHER RESOLVED, that the Shandaken Town Board hereby authorizes the Town of Shandaken to pay in the first instance 100% of the federal and non-federal share of the cost of right-of-way acquisition, construction and construction inspection work for the Project or portions thereof; and

BE IT YET FURTHER RESOLVED, that the Shandaken Town Board hereby agrees that the Town of Shandaken shall be responsible for all cost of the project which exceed the amount of the NY Bridge Funding awarded to the Town of Shandaken and that the sum of **\$740,000** is hereby appropriated from the Town of Shandaken Highway Budget and made available to cover the cost of participation in the above

phase of the Project; and

BE IT YET FURTHER RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Shandaken Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Town Supervisor thereof, and

BE IT YET FURTHER RESOLVED, that the Town of Shandaken hereby agrees that construction of the Project shall begin no later than eighteen (18) months after award and that the project shall be completed within three years of commencing construction; and that the Supervisor of the Town of Shandaken be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or State-Aid on behalf of the Town of Shandaken with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and

BE IT YET FURTHER RESOLVED, that in addition to the Town Supervisor the following municipal titles: Highway Superintendent, Town Engineer are also hereby authorized to execute any necessary Agreements or certifications on behalf of the Municipality/Sponsor, with NYSDOT in connection with the advancement or approval of the project identified in the State/Local Agreement and that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project; and

BE IT YET FURTHER RESOLVED, this Resolution shall take effect immediately.
