Deputy Supervisor's Report - Robert Drake

Supervisor DiSclafani has a family emergency that prevents him from attending today. We wish him and his family the best.

Congratulations to Sarah Engster for becoming our next Town Justice.

Please note that the town burn ban is in effect indefinitely.

On a related note, due to how dry it has been our water districts are lower than we'd like. Please make reasonable efforts to conserve water.

The county has identified parcels for emergency radio towers / cell service but those projects are not currently the highest priority. We encourage all residents to reach out to the county and request these projects get escalated. We will be doing the same in our roles on the town board.

The conservation advisory council recently held a meeting on emergency preparation. One action from that was around "plum cases". These are communication devices to be used in a disaster. Chief Storey will be evaluating whether these may be useful for the town to purchase.

The towns NY Forward application has been submitted and we hope to hear back within November.

With the help of Heidi Emrich, we submitted a SMIP grant to hire firm to help us retain and improve our community rating system FEMA flood designation.

The Big Indian parcel that was identified as a potential town hall location belongs to the DEC. They are currently evaluating how they might disband the conservation easement and make this parcel available.

Belleayre recently announced Mountain Jam June 20-22. County and local emergency services are aware and will be preparing for the event.

Bonadio is finalizing their town audit. We have contracted with them to provide staff training, create an updated handbook of controls, and perform the towns future annual financial reporting to the state.

We have signed an agreement to get access to the Bottini parcel in Pine Hill to perform an environmental study ahead of any potential acquisition.

The planning board will be considering a draft resolution to set a "payment in lieu of parking" fee that may be used by applicants trying to meet statutory parking requirements in hamlet commercial zones. This law exists on the books but has never had a defined fee schedule.

The new members of the Phoenicia water committee met and will host their next meeting on the 18th of November at 6:30pm. A location is being identified and will then be published.

Stormwater run off for pine hill is currently a grant with CWC awaiting approval.

Thank you Gary Carr for building the town hall handicap ramp. Thank you everyone involved in upgrading the skate park at Smith Park.

The Monthly Report for The Shandaken Historical Museum for October 2024

The Museum participated in the Phoenicia Farmer's Market throughout the month of October offering the public a range of items from our museum table. There continues to be great interest by the community to interact, visit and make use of the museum.

On Oct. 13th Cynthia Nikitin of the Brunel Park Sculpture Garden gave an intriguing presentation on the life and work of French photographer, sculptor, and Catskill entrepreneur Emile Brunel. The event was attended by almost two dozen people. An exhibit on the Brunel Park Sculpture Garden was also up for the month of October. It is through Cynthia Nikitin that the museum is now listed on the I Love New York Pathway Through History.

On October 25th the museum met with two archivists from the New York State Archives to receive a replica of the 1678 Nichols Treaty Esopus Indian wampum belt on loan to the museum for display during National Native American Heritage Month along with instructive publications covering our state's early interactions with indigenous tribes. The New York State Archives is part of the Office of Cultural Education, an office of the New York State Education Department.

The Town of Shandaken helped to purchase two new dehumidifiers for the Museum. We are working to improve overall heating and dehumidifying issues in the building. We are looking into decarbonizing strategies and possible EV parking in coordination with some of our upcoming grant proposals.

Grants for several new exhibits are being prepared and submitted for next year including a NY Forward Grant in collaboration with Jan Jaffe and the Wellington Hotel in Pine Hill, NY. The plan is to start applying for grants that would help fund interactive exhibits to enhance the quality and depth of our exhibitions attracting more visitors and tourists to Pine Hill and to the Museum. The Museum plans to offer events and promotions coordinated with local entities like the Wellington Hotel, the Pine Hill Community Center, the Morton Memorial Library, the Pine Hill Rail Trail, the Belleayre Mountain Ski Resort, the Phoenicia Business Association and the Emerson Hotel. Through better marketing and event programming, the museum plans to attract visiting tourists through regional media ads and robust social media engagement.

There were over 35 visitors in October to the Museum from all over including a family visiting from Malaysia. Many of the Museum visitors are regional history buffs doing research. They often left donations and grateful messages.

Most of the time they stagger these on site visits opposite to the year the Ambulance recertifies, this time they did not. So as imagined it has been all hands on deck as we prepare for the site visit, and we're sure we'll do great as we have for years past.

We would also like to welcome a new addition to our Squad following his appointment tonight. Joseph Carmody comes to us from Saugerties as a part time Paramedic. Joe also works at Diaz Ambulance, and is a Volunteer Firefighter at the Saugerties Fire Department. He's a good catch!!!!

Please exercise EXTREME CAUTION in regards to anything that can create a spark or flame outdoors. This includes discarding smoking materials, wood stove resedue, etc. in the Town of Shandaken. We are still in a burn ban that was effective October 24th.
