# SUPERVISOR'S NOTES - AUGUST 2025

Tonight, we will be having a presentation from Dr. Eve Walter, Ph.D., Public Health Director for the Ulster County Department of Health to tell us about services they offer residents.

We have a presentation scheduled for before our next regular meeting September 8<sup>th</sup> from 5:30 to 6:30 – before our regularly scheduled meeting, about research and designs produced by our Engineering firm SLR. They will outline flood mitigation efforts and enhancements we could employ if we find funding and, in some cases, we acquire certain properties that may become available.

#### We have resolutions;

- setting a public hearing amend Town code allowing alternates on our Planning Board and Zoning Board of Appeals
- Setting a public hearing amend our Telecommunications Law.
- to acquire the Phoenicia School for \$1.00 to be used as Affordable Housing. We will need to take bids and offers from developers.
- -to hire a contractor to build a natural playground in Glenbrook Park.
- -to hire Shadbush Consulting to create a Shandaken Natural Recourses Inventory.
- and hire Hudsonia, Ltd. to do GIS mapping as part of that NRI
- -update and amend or ARPA funding
- -appoint dog kennel volunteers and recycling attendant.

As part of our CRS Community Rating System outreach, for those in the floodplain area that have experienced 'Repetitive -Loss' or have had any insurance claims from flooding, we will have an open house for you on August 25<sup>th</sup> here at the Town Hall. Heidi Emerich from Ulster County Office of the Environment and I will hear from 11am- 2pm Stop in my office when you arrive. We will be moving forward, if the Town Board agrees, to have a Local Flood Analysis LFA for Chichester. Much like the Phoenicia Mt. Tremper, Shandaken and Pine Hill LFA's AWSMP will be our Agent. We have put a request to our Engineer, SLR for a plan and quote.

There are a couple properties that look good for the Town Hall/ Highway complex and we need to go into executive session to discuss our options.

I want to offer thanks and appreciation to two long-standing members of our Town employees, who are resigning from their positions; John Horn and Joseph Rotella Sr. Thank you and best wishes to your future.

Of course weekends are the busiest for call volume this time of year, and that extends to our surrounding Ambulance Services as well. From time to time we will provide mutual aid into neighboring areas, and vice versa- but sometimes call volume is so extreme that assistance from afar is needed due to EVERYONE being as busy as Shandaken at the same time.

On July 22 call volume in the County was extreme. As Shandaken was operating with Olive at a rollover motor vehicle accident with over 5 patients, other calls occurred in the Town. Hearing the call volume, and the numerous Departments handling other calls surrounding us, Chief Charles Foster of the Marbletown Rescue Squad sent one of his crews to respond to a call on the West end of the District as no other units were available.

Not since Hurricane Irene has a Marbletown Ambulance operated in Shandaken, and just like in 2011 we are incredibly grateful that Chief Foster, and his crew took the trip to help a Town in need. Teamwork makes the dreamwork as they say, and we'll have your back when you need us!

#### The Monthly Report for The Shandaken Historical Museum for July 2025

On Saturday, July 5<sup>th</sup> the Museum met with historian and former Chichester postmaster, Charlie Zimmerman, to work on a series of upcoming multimedia presentations about the town of Shandaken and its 12 hamlets. The project is in collaboration with Pine Hill's Morton Memorial Library and may be presented at the Phoenicia Theater. The first presentation in mid-October will be about the history of Chichester.

The Museum has been working with Joyce Grant and the Town of Shandaken on doing research for a historical sign commemorating the M. E. Methodist Church in the Oliverea Cemetery.

On July 12<sup>th</sup> the Museum helped to celebrate Pine Hill Pride Day. The Museum wishes to congratulate the event's organizers on its great success.

On Friday July 25<sup>th</sup>, the Museum board met with reporter Conner Grecko from the Daily Freeman for a feature story on the Shandaken Historical Museum that will include an interview of museum staff and photos. Noted author and historian Evan Pritchard will present Part 2 his Turtle Tracks presentation on August 16. In this unique and exciting armchair adventure, he will guide us on a virtual journey along the Turtle Island Trail, now known as Route 22, from Montreal Canada to Louisville, KY. Through maps, photos and historical text we will complete this epic journey, ending on Corn Island at the Falls of the Ohio River, arriving at dozens of Native American historical sites along the way. Evan suggests that you bring your mental hiking boots! The Museum will be holding our metal detecting weekend of August 9<sup>th</sup> and 10<sup>th</sup> working with the Nor'easters Metal Detecting Club from Stamford CT. This metal detecting adventure is available free for local property owners to find and unearth potentially rare or historically important metal treasures. The Nor'easters have helped sponsor the Museum for almost a decade. We look forward to literally digging into the history of Shandaken at many local sites.

The series of live concerts at Big Indian Park will continue on Sunday, August 10<sup>th</sup> and 24<sup>th</sup> and again on Sunday, September 7th. Come out for great fun, handcrafted local cider, brews, wine, and a great food truck. It's family friendly and dog friendly too! No Cover!

In June the museum had 40 visitors. Many leaving generous contributions and messages of thanks and appreciation.

Resolution to schedule a Public Hearing for the purpose of amending town code to allow for alternate members to the Planning Board & Zoning Board of Appeals.

Whereas, the Shandaken Town Board proposes Town Law #1 of 2025 – Alternate Members of Planning Board and Zoning Board of Appeals, with the following language to be added/amended in town code. *Proposed Addition Section 39-1.2* 

### **Alternate Members**

- A. This section is enacted to provide a process for appointing alternate members of the Planning Board.
- B. Two alternate members of the Planning Board may be appointed by the Town Board for terms of up to two years, with the terms to expire on December 31 of the second year after the date of their initial appointment.
- C. The Chairperson of the Planning Board shall designate an alternate to substitute for a member when such member is unable to participate on an application or matter before the Board owing to a conflict of interest or when a member notifies the Chair that he or she will be absent for two or more consecutive meetings. When so designated, the alternate member shall possess all the powers and responsibilities of such member of the Planning Board. Such designation shall be made by the Chairperson on a rotating basis commencing with the alternate first appointed by the Town Board following the effective date of this

- section. Each designation shall be entered into the minutes of the initial Planning Board meeting at which the substitution is made.
- D. Alternate members shall regularly attend the scheduled meetings and/or work sessions of the Planning Board to which they may be designated so as to be available for designation when required and to be familiar with the applications and/or matters pending before such Board.
- E. Alternate members shall serve without compensation.
- F. All provisions of state law relating to Planning Board member attendance, eligibility, vacancy in office, removal, compatibility of office and service on other boards, as well as provisions of any local law or ordinance relating to training and continuing education, shall also apply to alternate members.

Proposed Modification to Section 39-10 C (1) (e)

- (e) Chairman shall inform members of the training and continuing education courses as required by New York State General Municipal Law for all planning board members, including alternates. *Proposed Modification to Section 39-10 C (3) (a) [3]* 
  - [3] Serving as custodian of the records of the Planning Board, including records of training and continuing education as required by New York State General Municipal Law for all planning board members, including alternates.

Proposed Addition to Section 116-67 A

#### A. Alternate Members

- 1. This section is enacted to provide a process for appointing alternate members of the Zoning Board of Appeals.
- 2. Two alternate members of the Zoning Board of Appeals may be appointed by the Town Board for terms of up to two years, with the terms to expire on December 31 of the second year after the date of their initial appointment.
- 3. The Chairperson of the Zoning Board of Appeals shall designate an alternate to substitute for a member when such member is unable to participate on an application or matter before the Board owing to a conflict of interest or when a member notifies the Chair that he or she will be absent for two or more consecutive meetings. When so designated, the alternate member shall possess all the powers and responsibilities of such member of the Zoning Board of Appeals. Such designation shall be made by the Chairperson on a rotating basis commencing with the alternate first appointed by the Town Board following the effective date of this section. Each designation shall be entered into the minutes of the initial Zoning Board meeting at which the substitution is made
- 4. Alternate members shall regularly attend the scheduled meetings and/or work sessions of the Zoning Board of Appeals to which they may be designated so as to be available for designation when required and to be familiar with the applications and/or matters pending before such Board.
- 5. Alternate members shall serve without compensation.
- 6. All provisions of state law relating to Zoning Board of Appeals member attendance, eligibility, vacancy in office, removal, compatibility of office and service on other boards, as well as provisions of any local law or ordinance relating to training and continuing education, shall also apply to alternate members.

Scheduling A Public Hearing On Local Law No 2 Entitled "Amending the Town Code Section 116 Regarding Telecommunication Facilities"

**Whereas**, the Town of Shandaken's Comprehensive Plan of 2005, (the "Plan") notes: "The placement of signal transmission equipment is essential to the operation of wireless telephone services for the residents, visitors and emergency service providers; and

Whereas, the Plan also indicates that "Emergency Communication – An alternative emergency communication system needs to be identified in light of Verizon's recent announcement that it will be eliminating many of the public telephones in the Town": and

**Whereas**, the survey conducted in association with the outreach effort to update the 2005 Comprehensive Plan identified cell service/emergency communication as one of the Town's top three concerns; and

**Whereas**, the City of New York Department of Conservation announced in 2024 an initiative to improve cellular communication in the watershed recognizing the risk to its water supply lands due to poor cellular communication; and

**Whereas**, the Town of Shandaken continues suffer from lack of cell service in part due to the limited opportunities for siting cell towers and costs associated with their construction on difficult terrain; and

**Whereas**; the Town Board recognizes the significant public safety need and is desirous of removing barriers and increasing the opportunities for the siting of cellular and other public safety communication facilities; and

**Whereas**; the Town Board has been presented with and has introduced a draft Local Law No. 2 of 2025 entitled "Amending the Town Code Section 116 Regarding Telecommunication Facilities as annexed to this resolution; now therefore be it

**Resolved**, that pursuant to Section 20 of the Municipal Home Rule Law of the State of New York, a public hearing on said proposed Local Law No. 2 shall be held on September 8<sup>th</sup>, 2025 at 6:30pm at the Town Hall, located at 7209 Route 28 in the Town of Shandaken, New York, and that notice of the time and place of such hearing describing in general terms the proposed local law, be published once on or before the 8 day of September 2025 in the Daily Freeman, a newspaper circulating in said Town of Shandaken . and be it further

**Resolved**, that the Town Board has determined that Local Law# 2 constitutes an Unlisted Action under 6NYCRR Part 617.4 (SEQRA) and will act as Lead Agency in the environmental review of this action; and, be it further

**Resolved**, that the Town Board hereby authorizes the Town Supervisor to refer Local Law #2 to the Ulster County Planning Board pursuant to Section 239m of the NY General Municipal Law.

# Draft Local Law #2-2025

Proposed Change to Section 116-14 (3)

(3) The maximum height for telecommunication towers permitted under this article, including any antennas or other devices extending above the tower, measured from the original ground level at the base of the tower, shall be up to 199 feet.

Proposed Replacement of Section 116-62.4 (H) and (I)

- (H) REMOVED
- (I) Minimum setbacks. The minimum distance between the base of a tower-based wireless telecommunications facility and any adjoining property line or street right-of-way line shall equal 100% of the proposed height of the tower-based wireless telecommunications facility, unless the applicant shows to the satisfaction of the Town Board that the proposed tower-based wireless telecommunications facility has been designed in such a manner that a lesser setback will have no negative effects on public safety.

**WHEREAS**, representatives from Ulster County will provide to the Town legal advice and introductions to prescreened developers who specialize in area affordable housing projects,

**NOW THEREFORE BE IT RESOLVED**, the Town Board agrees to enter into discussions with the Ontora School District to acquire the Phoenicia Elementary School property; and

**BE IT FURTHER RESOLVED**, the Town Board will move forward, pending approval in a public referendum, with interviewing suitable developers for the purpose of creating affordable housing and community space for the Town of Shandaken.

### OBLIGATING ARPA FUNDS- UPDATED

WHEREAS, in 2021 and 2022 the Town of Shandaken received \$301,229.86 from the American Rescue Plan Act (ARPA) Local Fiscal Recovery Funds; and

**WHEREAS**, the Town has many eligible capital projects including infrastructure, machinery, and equipment,
