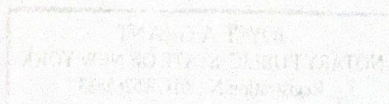

2. Sign Details

The proposed sign will have the following approximate specifications:

- Size: 24 inches (W) x 30 inches (H)
- Height above grade: 4 feet
- Materials: Matte-black powder-coated aluminum frame with a rigid aluminum composite (ACM) sign panel
- Color scheme: Matte black frame with forest-green logo and charcoal-gray text on a neutral off-white background
- Lighting: No lighting (unless otherwise specified)
- Installation method: Two vertical posts anchored with ground spikes or concrete footers (depending on soil conditions), with the sign panel bolted directly to the cross-beam.

3. Duration & Maintenance



The Applicant is responsible for installation, maintenance, repair, and removal upon request with reasonable notice. Permission may be revoked by the Property Owner with 30 days' written notice.

4. No Transfer of Ownership

This Agreement does not grant any ownership interest in the land. It is simply permission to place the sign.

5. Planning Board Requirement

This agreement is intended to satisfy the Town of Shandaken Planning Board requirement for written, notarized approval for signage placed on property not owned by the Applicant.
