It is evident that completing the District's Emergency Response Plan is of highest priority. We are so grateful that Board Member Steen has stepped up to serve as Deputy Superintendent and has already completed about a quarter of that Plan.

Board Member Drake reported that the results of the survey are on the website. The consultants, Pattern for Progress is seeking a new director.

Board Member Drake stated that the discussion of the Memorandum of Agreement for the Ambulance be moved to the end of the month as this must be posted publicly.

The Monthly Report for The Shandaken Historical Museum for November 2025

During the first weekend of November, new Museum assistant, Marianne Zurah helped clean up and organize the old Museum storeroom. Her diligent work has been a vast improvement for the museum and its goal of documenting the entire museum collection, improving the use of all available space and smarter organization.

The Museum is working with the Hotel Wellington's Jan Jaffee who submitted a new and updated application for a New York Forward grant. In it, the Museum submitted new projects and improvements. The focus of Jan's application is to make use of a newly redeveloped Pine Hill to generate money, traffic, and more cultural events in the area. The Museum plans to work closer with the Pine Hill Community Center, and the Morton Memorial Library to develop shared cultural and educational events and exhibits

On Friday Nov 14th Stairlift company National Seating and Mobility visited the Museum to measure and discuss installing a stairlift between the first and second floors. It will be non-intrusive, remote controlled and industrial strength. The company is national and 100% American and veteran owned. The Museum is currently making plans to become completely handicap accessible by the end of 2026. On Saturday, November 22nd Catskill hiking expert, historian and carpenter Paul Misko gave a multimedia presentation at the Museum called "Woodworking in the Catskills." His presentation included woodworking in olden days, as well as in current times. Harvesting the wood, milling the logs, and making the household items. Paul showed the various kinds of wood species that the Catskills provides, and demonstrated various popular projects for each type.

On Saturday November 29th, to celebrate Native American Heritage Month, the Museum hosted a Native American musical drum circle lead by flautist Laurie Asperas and long-time Big Indian resident Robert Cruickshabk along with members from the Spirit of the Mountain Drum Singers. A crowd of over fifty local people attended partially due to the museum's new media strategy. The songs and stories told promoted spiritual strength, joy and harmony to those who gladly attended.

The museum had over 65 visitors in November. Many leaving generous contributions and messages of great thanks and appreciation.

FURTHERMORE, SHE ALSO STATED THAT THE PLANNING BOARD DID NOT FINALIZE THE SPECIAL USE PERMIT FOR FOXFIRE. HER CONCERN WAS WHAT DO WE DO IF A BUSINESS EXPANDS BEYOND THE ORIGINALLY REQUESTED SPECIAL USE PERMIT.

SHE REPORTED THAT ROBERT LIEBOWITZ HAS BEEN TRYING TO GET SHANDAKEN TO TIGHTEN UP ZONING LAWS AND HE HAS NOT BEEN SUCCESSFUL.

THE BOARD AGREED TO LOOK AT THE ZONING CODE AND WILL BRING MOLLY HOLM AND OTHER RESIDENTS INTO THE CONVERSATION.

JOANNE LEWIN- JACUS DISCUSSED HER REQUEST THAT THE BOARD ADOPT A RESOLUTION DENOUNCING THE FEDERAL BIG BEAUTIFUL BILL. THIS RESOLUTION HAS BEEN PRESENTED TO OTHER TOWNS ACROSS ULSTER COUNTY. SHE IS REQUESTING THAT THE BOARD ADOPT THIS RESOLUTION.
